The Craven Community College Board of Trustees met on Tuesday, September 19, 2023 in the Brock Administration Building, Ward Boardroom with Board Chair Dr. Ervin Patrick presiding. The meeting was called to order at 5:30 pm.

Roll Call

President Raymond Staats called the roll.

Board Chair Patrick declared a quorum present and welcomed everyone to the September board meeting.

WFD Update

VP Gery Boucher highlighted Workforce Development reports and campus events (attached). He also reviewed Workforce Developments' five-year enrollment trends and ten-year FTE trends.

Old Business

Approve BP 2.37 Paid Parental Leave: President Staats reviewed BP 2.37, Paid Parental Leave, (attached) which had been presented in August for Trustee review, for approval. Trustee Roberts motioned to approve the new board policy as presented; Trustee Wallace seconded the motion and the motion was unanimously approved.

Approve Revised Closure 3-1 for Bate Community Life Center Project # 1790: The Bate Community Life Center Project was canceled in 2011. The North Carolina Community College System office shows the project as open with \$2,660.00 remaining. After closure, the remaining funds will be transferred to an active construction project. Trustee Taylor motioned to close Project # 1790; Trustee Hughes seconded the motion and the motion was unanimously approved.

Approve Amendment to 3-1 for Windows and Doors Project # 2605: Trustee Roberts motioned to approve that the remaining funds of \$2,660.00 from closed Project # 1790 be moved to active Project # 2605; Trustee Wallace seconded the motion and the motion was unanimously approved.

New Business

Annual Security Report: VP Jim Millard presented the annual security report for informational purposes (attached). The annual security report will be posted to the college website as

required by the Jeanne Clery Disclosure of Campus Security Police and Campus Crime Statistics Act.

Final Audit Determination: VP Jim Millard reviewed the State Final Audit Determination for Fiscal Year 2022 (attached) for information. This audit of Craven Community College showed no deficiencies and no further action is needed.

Department of Veteran Affairs Risk-Based Survey: VP Gery Boucher presented a letter (attached) from the North Carolina State Approving Agency (NCSAA), confirming that no discrepancies were found during the review of beneficiary records, no further action is needed.

Biennial Evaluation Letters: President Staats presented letters received from the North Carolina Ethics Commission that evaluated the Statement of Economic Interests for the Board of Trustees that were submitted in March. Jennifer O'Neill, Ervin Patrick, Dr. Raymond Staats, and Tabari Wallace received evaluations indicating no conflict of interest is present. James Davis Jr., Pamela Holder and Sandra Phelps received notice of a potential for a conflict of interest, due to their respective employers may conduct future business with the College.

Architectural Design Bid Delegation of Authority for Corporate Training Center Project: President Staats noted the design bid process for the Corporate Training Center will close shortly after the September board meeting. The earliest Trustee approval of the architect selection would be during the October board meeting unless a special-called meeting is scheduled. Trustee Taylor reviewed the three finalists and is satisfied with their qualifications. Upon motion by Trustee Roberts, and second by Trustee Hughes, the Board unanimously delegated selection authority to the President from among the three finalists. Dr. Staats will review the final selection with Trustee Taylor and Chair Patrick.

- State Budget draft was released. Stipulation for community college president contracts was not in the draft. The budget includes various salary increases, state income tax reductions.

Whereas, Mr. Harold H. Bate was born August 21, 1907, was raised in New Jersey, and graduated from Cornell University with a Bachelor's Degree in Forestry, and,

Whereas, Mr. Harold H. Bate worked in his family's lumber business, and moved to North Carolina in 1964 to expand business interests, where he oversaw the operations of multiple sawmills and acquired large tracts of timberland in Eastern North Carolina, and,

Whereas, in 1996, Mr. Harold H. Bate made his first major philanthropic gift to the Craven Community College Foundation of more than ninety-five thousand dollars from timber sales, and,

Whereas, Mr. Harold H. Bate formed the Harold H. Bate Foundation in 1999 to advance and perpetuate his philanthropy, and,

Whereas, the mission of the Harold H. Bate Foundation is to offer financial support to the communities of Craven, Pamlico, and Jones County, with special consideration of East Carolina University, Craven Community College, and the Twin Rivers YMCA, and,

Whereas, since his passing in 2000, the Harold H. Bate Foundation has continued his generous legacy in accordance with his philanthropic vision to administer charitable gifts wisely to enhance education, youth and recreation, and quality of life, and,

Whereas, to date, the Harold H. Bate Foundation has donated more than three million two hundred thousand dollars to the Craven Community College Foundation in support of the College's students, and, Whereas, the naming of a College Building is an honor carefully reserved for those individuals and organizations who have made a uniquely distinctive multi-generational impact upon the College and its student body.

Now therefore, the Trustees of Craven Community College resolves, this 17th day of October, Two Thousand and Twenty-Three, that "Building H," located on the New Bern Campus and previously referred to as the Business and Information Technology Building, shall henceforth be named

Harold H. Bate Hall

The Foundation kicked off its annual campaigns in August with the combination of a solicitation mailing for the Community Campaign and the hand delivery of pledge forms to staff and faculty for the Campus Campaign. Foundation staff visited with individuals and attended the various Unit and Department Meetings on both campuses as well as the Volt Center to talk about the accomplishments of the Foundation as well as the importance of support. This year's Community Campaign is co-chaired by Si Seymour, former Craven CC employee and member of the Harold H. Bate Foundation and Katrina Bishop, Associate Dean of Liberal Arts and University Transfer, Math Science & Social Science, Craven Community College. As of October 3rd, the two campaigns combined have raised \$54,806. Funding for endowments, grants and scholarships from other sources total \$122,468 for a combined amount of \$177,274 raised fiscal year to date.

The combined value of the Foundation's assets remains stable. As of June 30, 2023 (the end of the fiscal year), the endowment portfolio was funded at \$2,942,760 and other assets at \$920,732 (including prepaids and other current receivables of \$10,389) for a combined total Fund Balance of \$3,863,492. The funds on hand will ensure that the Foundation is well positioned to cover any market instability. Funding from endowments will provide \$77,151 in scholarships this fiscal year. This is a marked decrease from the previous year fueled by the downturn in market performance in calendar year 2022. The Foundation supplemented scholarships with an additional \$75,000 from reserve funds to help alleviate the shortfall. Additionally, we received scholarship funding from the Harold H. Bate Foundation for the year at \$125,000. The Foundation has budgeted \$442,805 for student assistance for the year.

The Foundation had a very successful Donor – Recipient Reception this year on September 12th, 2023. The event was well attended with over 120 students, donors, staff and faculty. Many of the donors commented that it was good to speak with the students' receiving assistance and to hear their stories.

The Lifetime Learning Center (LLC) is in full swing with events. Recent trips by the LLC include the Grand Canyon tour and Wicked at the Durham Performing Arts Center. Upcoming events in the near future include MJ The Musical, Flamenco Dancers (including performances at area K-12 schools) as well as the Foreign Film Series at Orringer Auditorium.

The Foundation continues to show substantial financial support, despite the uncertainties caused by market fluctuations. We continue to see a steady number of Campus Campaign gifts and expect that number to rise as we kick off the Angel Gift drawings for staff and faculty this month. The increase in funds from the Campus and Community Campaigns as well as the continued success in endowment and scholarship solicitations, show great support from both internal as well as external constituents.
